

BULLCREEK LEEMING JUNIOR FOOTBALL CLUB POLICY

- TO ENCOURAGE AND PROMOTE THE GAME OF AUSTRALIAN RULES FOOTBALL PLAYED BY MEMBERS OF THE CLUB.
- TO PROMOTE GOOD FELLOWSHIP, TRUE SPORTSMANSHIP AND CITIZENSHIP AMONG FOOTBALLERS, COACHES, SUPPORTERS, GUARDIANS AND PARENT'S.
- TO PROVIDE SUITABLE FACILITIES AND PROMOTE HEALTHY SOCIAL LIFESTYLE, RECREATION, ENTERTAINMENT AND AMUSEMENT TO ALL MEMBERS.
- PARENTS WHO HAVE PLAYERS IN AUSKICK TO 12'S ARE REQUESTED TO STAY WITH THEIR CHILDREN DURING TRAINING SESSIONS & GAMES OR ORGANISE A CARER. THIS IS A REQUIREMENT UNDER THE CLUB'S DUTY OF CARE POLICY.
- ALL PLAYERS REGARDLESS OF GENDER, SIZE OR ABILITY WILL BE GIVEN EQUAL GAME TIME FROM AUSKICK TO 12'S.
- COACHES FROM AUSKICK TO 12'S WILL PRODUCE A TEAM SHEET FOR ALL GAMES DISPLAYING TEAM ROTATION FOR ALL QUARTERS. ALL PLAYERS ARE TO BE ROTATED EACH QUARTER.
THE TEAM SHEET IS TO BE PRODUCED ON REQUEST FROM COMMITTEE MEMBERS AND PARENTS / GUARDIANS.
- PLAYERS IN 13'S -17'S ARE TO BE TREATED EQUALLY AND FAIRLY. THEY ALL WILL BE ENTITLED TO PLAY ½ GAME REGARDLESS OF POTENTIAL, SIZE, OR TALENT. COACHES ARE TO ENSURE ALL PLAYERS ARE GIVEN THE SAME AMOUNT OF BENCH TIME THROUGHOUT THE SEASON. THIS INCLUDES THE SUPERIOR PLAYER AS WELL. IF THIS DOES NOT EVENTUATE COACHES WILL BE ASKED TO EXPLAIN AND MAY HAVE THEIR ACCREDITATION RESCINDED.
- TO ENSURE ALL COACHES AT BULLCREEK LEEMING ARE ACCREDITED BY THE FOOTBALL DEVELOPMENT TRUST.
- AFTER A PERIOD OF THREE YEARS ALL COACHES WILL HAVE THEIR POSITIONS REVIEWED TO SEE IF THEIR SERVICES WILL BE RETAINED.
- TO ENCOURAGE ALL MEMBERS TO SUPPORT CLUB OFFICIALS TO FOSTER HIGH STANDARDS OF BEHAVIOUR FOR THE CLUB AND THE DISTRICT.
- ILLICIT DRUG TAKING WILL NOT BE TOLERATED AT B.L.J.F.C. AND WILL INCURE AN IMMEDIATE SUSPENSION.
- REMEMBER SMOKING AND THE CONSUMPTION OF ALCOHOL IS UNACCEPTABLE AT GAMES.
- ALL PLAYERS FROM AUSKICK THROUGH TO 17'S ARE TO ENSURE THEY WEAR A MOUTHGUARD TO TRAINING AND GAMES. THIS IS A REQUIREMENT UNDER THE CLUB'S DUTY OF CARE POLICY. NO MOUTHGUARD NO GAME. IF AN INJURY OCCURS AND NO MOUTHGUARD IS WORN YOU MAY JEOPARDISE YOUR INSURANCE CLAIM. ALL PARENTS ARE TO URGE THEIR CHILDREN TO WEAR A MOUTHGUARD.
THIS POLICY IS TO BE STRICTLY ADHERED TO.
